## GIFT VOUCHER TERMS & CONDITIONS

### GENERAL TERMS & CONDITIONS

- 1.1** — These terms and conditions apply to all Hotel Esplanade Gift Vouchers. The conditions may be updated at Hotel Esplanade's discretion from time to time.
- 1.2** — Gift Cards are only available for purchase and use at Hotel Esplanade.
- 1.3** — The recipient of the gift should be notified of the terms and conditions by the purchaser of the voucher.
- 1.4** — All vouchers must be purchased online through [www.hotelesplanade.com.au](http://www.hotelesplanade.com.au)

### PURCHASING & REDEEMING VOUCHERS

- 2.1** — Gift vouchers are purchased online at [www.hotelesplanade.com.au](http://www.hotelesplanade.com.au)
- 2.2** — The recipient receives the voucher via email and must present it in venue to redeem the value of the voucher.
- 2.3** — The minimum value of the voucher is \$20 up to \$1,000. Online purchases are only accepted with Mastercard, Visa, American Express or Debit Card.
- 2.4** — Gift vouchers can be redeemed in venue at Hotel Esplanade for food and drink offerings only. Gift card holders must be over 18 years of age. Proof of age must be provided, if requested, with a Government approved identification document.
- 2.5** — When the total of a transaction exceeds the value of the voucher, you must pay the amount exceeding the voucher balance by another accepted payment method.
- 2.6** — Hotel Esplanade gift vouchers are valid for a period of 3 years from date of purchase. Once it has expired the remaining value is forfeited. The expiry date set by Hotel Esplanade is final.
- 2.7** — Gift vouchers cannot be used for any third-party transactions or events that may be running in venue. This includes but is not limited to Moshtix or any Arts events which may be taking place and otherwise ticketed.
- 2.8** — Gift Vouchers cannot be used to purchase further vouchers.
- 2.9** — The value of the voucher does not need to be redeemed in full in a single transaction, however no change or refund will be given. Further transactions require the voucher to once again be presented at the time of purchase.
